Attorney Jonathan Hullihan has been providing legal guidance within the state of Texas, working closely with the CCDF-USA Texas State Executive Director and many CCDF-USA County

Executive Directors (CEDs).

CCDF-USA is expanding quickly, and Jonathan has been out working with and visiting some of these county locations.

Additionally, attorney Jonathan Hullihan represented the CCDF-USA Legal Team as he was an active panel participant at the CCDF-USA Election Integrity Panel in September.

Both, attorneys Charlie Hardage and Jonathan Hullihan delved into the more recent and “hot topic” issue of the Konnech software system issues that have been brought to light since the arrest of Konnech’s CEO Eugene Yu.

The watchful eyes that are being placed upon counties known to have Konnech software have prompted much election integrity activity amongst many CCDF-USA county citizens. One direct result prompted the Alachua County (Florida) Supervisor of Elections (SOE) to issue a public statement concerning Konnech in Alachua County. CCDF-USA counties continue to press forward and investigate this software with the goal of eliminating the Konnech software in all counties.

Attorney Charlie Hardage has been investigating election case matters uncovering layers and analyzing the Electronic Registration Information Center, more commonly referred to as ERIC. The state of Florida has contracted with ERIC systems and many election integrity concerns have been revolving around this system.

On behalf of CCDF-USA an Amicus Brief was filed in the Supreme Court of Texas addressing election violations; stating there is a clear and present conflict with the Texas Legislature’s Constitutional authority and the Texas Secretary of State’s Election Advisory.

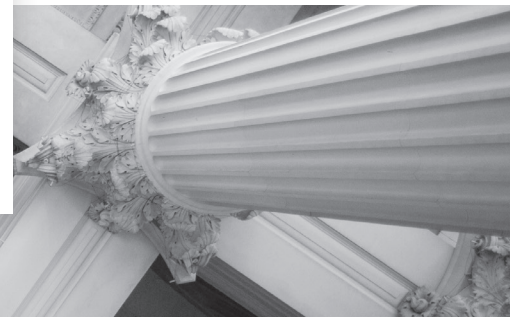

# MORE LEGAL NEWS

## ATTORNEY JEFF CHILDERS AND LEGAL HAVE BEEN ACTIVELY INVOLVED IN A LANDLORD HOUSING INSPECTION CASE.

Attorney Charlie Hardage explains, “The Gainesville City Commission passed an ordinance requiring all private, small (4 units or less) landlords in the city to pay a fee to be entitled to continue to rent out

their properties. Under the ordinance, the properties would also be forced to submit to periodic inspections and to meet energy efficiency standards set by the Federal Department of Energy. The result will

be increased rents for tenants who are already struggling to meet their living costs. This ordinance is an example of a heavy-handed local government importing regulatory standards from the Federal government into the local community to the harm of small businesses and consumers. We plan to challenge this ordinance on multiple legal grounds.”
